Statewide Weather Brief: Arizona received 9,185 lightning strikes (715 positive strikes) in the past 24 hours. Monsoon moisture will continue to bring a chance of showers and thunderstorms through Thursday. Strong high pressure and drier air will move into the area toward the end of the week.

Arizona State Forestry Activity: Arizona State Forestry received 6 wildfire reports and dispatched resources to 4 wildfires in the past 24 hours. No resources were dispatched to fires outside of the state in the past 24 hours.


